Race Format: 500m 4-lane sprints.

We recommend that you have at least 8 practice sessions and a competent steersperson in order to safely compete in the festival.

*MIXED CATEGORY: There must be a minimum of eight women paddlers in the boat at all times.

*WOMEN'S CATEGORY: Minimum of 12 registered teams required to run category. If insufficient registration, women's crews may race in the mixed category.

*OPEN CATEGORY:

Train for Gorge Fest and other local and regional festivals! All local teams in the Greater Victoria area wishing to enter a team in Gorge Fest must participate in a Dragon Boat Program. The **Fairway Gorge Paddling Centre** (FGPC) is the official local training centre for the festival and offers a wide variety of program options for all ages and abilities. FGPC also features **Millennium Dragon Boats**, which are used exclusively at Gorge Fest and the Victoria Dragon Boat Festival.

DISCLOSURE OF RISKS:

Participants in the Program must be physically agile and alert. Rowing and paddling sports have inherent dangers, hazards and risks, including, but not limited to:

Death from drowning or being exposed to hypothermia by falling into water;

Risks and dangers that occur when exposed to the forces of nature including unpredictable weather and waves. Abrupt weather changes and changes in conditions of water surface and variations in the water conditions, surfaces and currents.

Overturning or upsetting of the boat;

Poor swimming ability of the Participant or others;

Falling while moving about on slippery decks and ramps;

Accidents which occur while loading and unloading equipment.

Accidents from equipment failure and improper use of equipment.

Collisions with manmade or natural objects, motorized vessels or other paddlers or bystanders.

Facility & site hazards;

Negligence of others, including St. Michaels University School Society and the Fairway Gorge Paddling Club Society

TO: the Fairway Gorge Paddling Club Society and St. Michaels University School and their directors, officers, members, employees, volunteers, agents, independent contractors, subcontractors, representatives, successors and assigns (all of whom are hereinafter collectively referred to as the "Releasees").

IN CONSIDERATION OF the Fairway Gorge Paddling Club Society and St. Michaels University School permitting the Participant to participate in the Program and for good and valuable consideration, the receipt and sufficiency of which is acknowledged, the Participant voluntarily and knowingly signs this Disclosure of Risks, Assumption of Risks, Release of Liability, Waiver of Claims and Indemnity Agreement.

Definitions: "**Program**" means the paddling or rowing program detailed in box 6 above and shall include but is not limited to those activities as set out under the heading Disclosure of Risks which has been provided to and initialled in acknowledgement by the Participant.

ASSUMPTION OF RISKS

- I acknowledge that I am voluntarily participating in the Program. I understand that there are risks associated with participating in the Program which could result in injury, damage or loss to my own (or other's) property, body, or life.
- I understand that risks are inherent in the very nature of the Program and simply cannot be eliminated without jeopardizing the essential qualities of the Program. I am aware that the risks may include, but are not limited to, those risks listed in the
- Disclosure of Risks document.

 I understand that although the Fairway Gorge Paddling Club Society and St. Michaels University School strive to provide a safe environment during the Program, risks may result from human error and negligence on the part of persons involved in preparing, organizing and leading any Program.
- I understand that I have a personal responsibility to learn and follow rules and procedures established by the Releasees and to make them aware at any point in which I question my own knowledge of those procedures or my ability to participate in any of the Program.
- I voluntarily **accept and fully assume** all risks, dangers and the possibility of personal injury, death, property damage or loss resulting from participating in the Program.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

- To waive any and all claims that I have or may in the future have against the Releasees and to release the Releasees from any and all liability for loss, damage, expense or injury including death that I may suffer, or my next of kin may suffer, resulting from my participation in the Program, due to any cause whatsoever, including negligence, breach of contract, or breach of any statutory duty or other duty of care on the part of the Releasees;
 To indemnify and hold harmless the Releasees from and against all claims,
- demands, actions and suits and all liabilities, losses, damages, costs, charges and other expenses of every nature and kind, for any damage to property of or personal injury to any third party, resulting from the my participation or presence in the Program; and
- To hold harmless and indemnify the Releasees from any and all emergency expenses related to first aid or medical treatment and/or evacuation in the event of any accident, injury or illness. I acknowledge that all expenses associated with emergency evacuation, rescue or first aid will be my responsibility and will not be covered by the Releasees.
